## Mandatory Requirements

Only companies which fulfill the following requirements will be considered:

- 1. Business Registration: Must be at least a Malaysia-registered Sdn Bhd company.
- 2. **Experience:** Must have at least 1 successful end-to-end Core Financing/Loan Management System implementations specifically for Contract Financing product type (including data migration) in the financial services sector in Malaysia or Southeast Asia within the last 5 years.
- 3. **Industry Focus:** Primarily serving or having a large customer base in financial services (banks, insurance, DFIs, fintech).
- 4. **Capability:** Must have the technology, technical capability, on-prem and cloud deployment solutions, platform/ecosystem vision, and financial resources to form a strong, mutually beneficial, and long-term partnership with CGC.
- 5. Credit Standing: No adverse findings in CCRIS / CTOS.
- 6. **Pricing:** Proposal price must be valid for at least 90 calendar days.

- B. Vendor Code of Conduct (VCOC).

  - i. Services and market offerings of the company.
  - ii. Technology and technical capabilities.
  - iii. List of customers in the financial services industry.
- E. Industry Recognition & Awards provide details of any recognition/ranking/awards the proposed solution has received from reputable third-party organisations such as IDC MarketScape, Gartner Magic Quadrant, Forrester Wave, etc.
